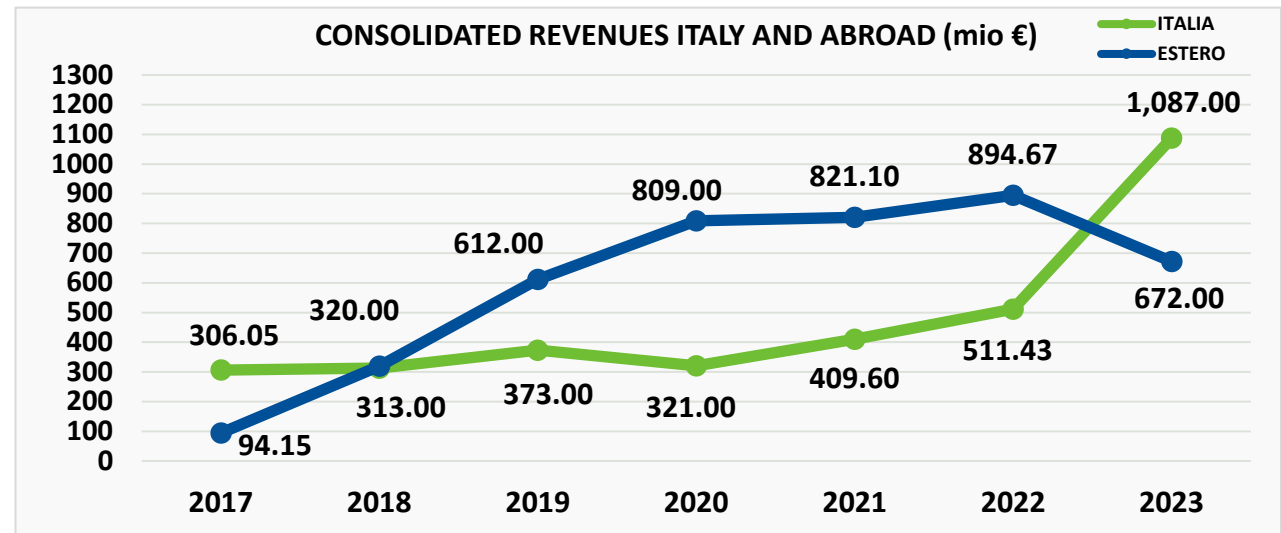
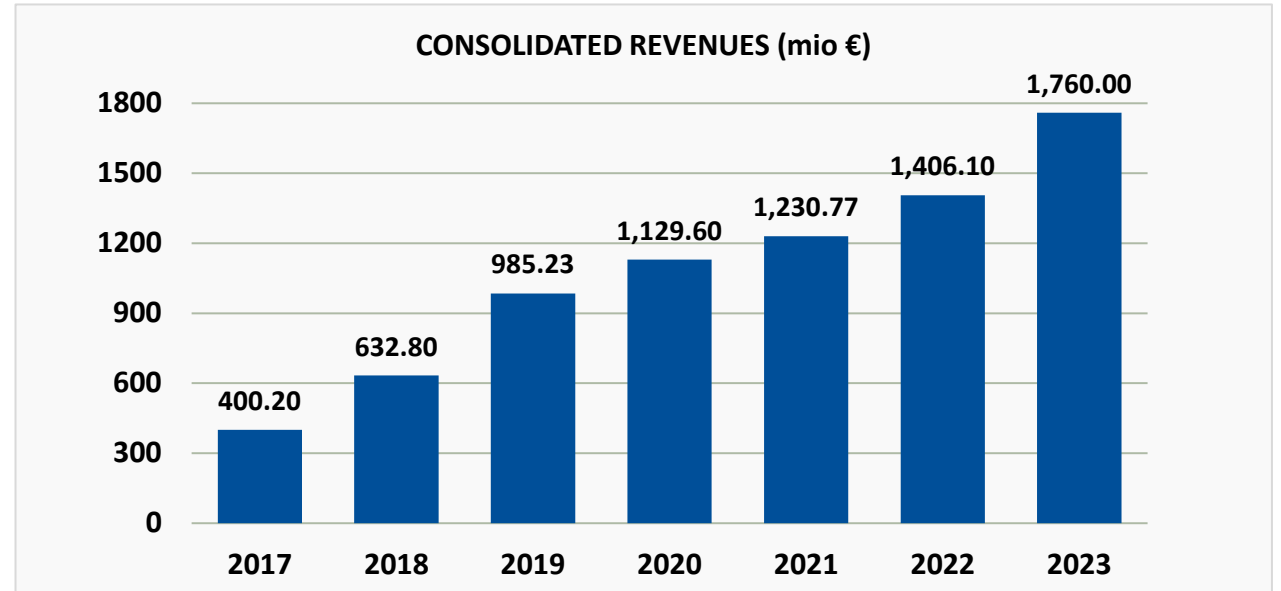

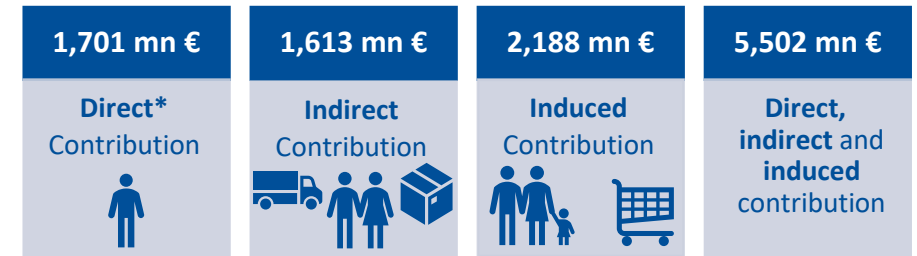


3 | Sustainability

- **Itinera** has adopted the new **2022-2026 ASTM Sustainability Plan**, that sets clear, measurable goals in areas like People, Planet, and Prosperity, driving specific actions for the coming years. These include scientifically based targets for reducing greenhouse gas emissions by 2030.
- **Itinera**, in the construction sector, focuses its sustainability plan on reducing energy consumption, minimizing environmental impact, protecting biodiversity, enhancing workplace safety, promoting diversity and inclusion, developing human capital, safeguarding human rights, and supporting community projects. The plan also aims to develop skills for designing and building low-impact transportation infrastructure and civil and industrial constructions.

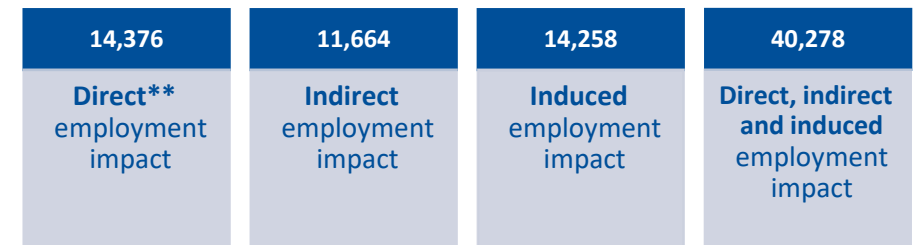

Science Based Targets

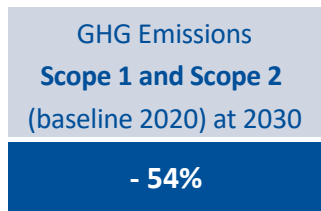
The Itinera Group, adapting to ASTM Group, remains at the forefront of the energy transition and the fight against climate change, defining targets for reducing **greenhouse gas emissions** (GHG) on a scientific basis.



GHG 2023 Emissions



Itinera continues the key objectives of the ASTM Group for the reduction of GHG emissions to 2030 approved by the Science Based Targets initiative (SBTi):



Emissions reduction plan 2020-30

- Heating efficiency:** We replace gas and diesel heating systems with high-efficiency, low-CO2 solutions, such as condensing systems or heat pumps, where permitted by building conditions.
- Sustainable mobility:** The renewal of our vehicle fleet translates into the introduction of electric and hybrid cars and the installation of their charging stations, as well as the promotion of low-emissivity and bio fuels.
- Renewable energy:** We purchase energy from renewable sources and install photovoltaic panels to increase energy self-sufficiency, aiming towards sustainable energy independence.
- Monitoring and control:** A system of continuous monitoring of energy consumption and CO2 emissions allows us to have a clear view of our impact and work to improve it constantly.
- Staff training:** The training of our staff is aimed at promoting a conscious and rational use of energy, with the aim of optimizing consumption and eliminating waste.

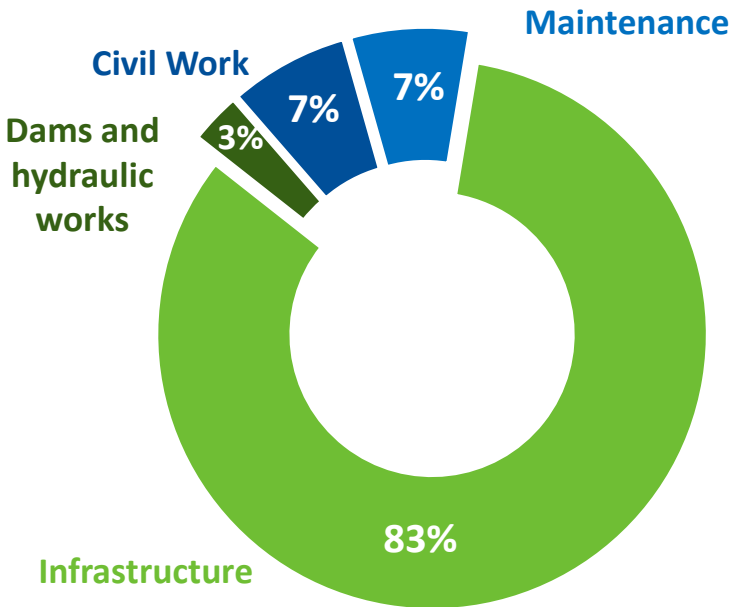

Consolidated Backlog (Dec. 2023)

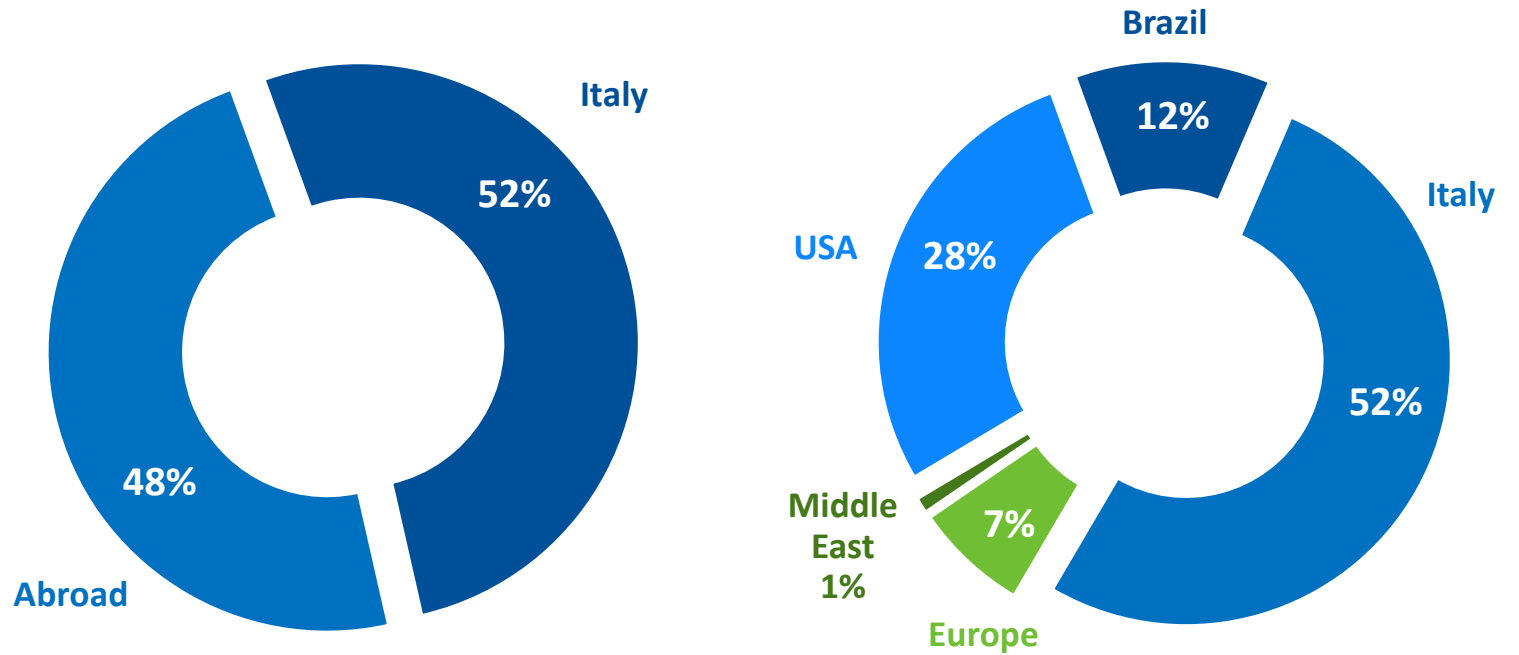
